LYME REGIS SEA ANGLING CLUB PRIVACY POLICY STATEMENT

On 25th May 2018 the General Data Protection Regulation (GDPR) became legislation changing the law regarding the holding and use of personal data such as names, addresses, phone numbers and email addresses.

GDPR is designed to protect your privacy and provide reassurance that personal data is being used responsibly and held securely.

Lyme Regis Sea Angling Club manages a database which holds your name, home address, email address and telephone number(s). This information is used only for the purpose of informing you about events, advising on matters relating to the Annual General Meeting and anything else that is relevant to the Club and its activities. This information is not processed or passed on to third parties for the purpose of sale or marketing, promotions etc. The information is held on a personal computer and is password protected and subject to safeguards.

Lyme Regis Sea Angling Club is mindful of the security that is needed as far as using and holding on file, images of children under 16 and will not release any images of fishing activity without first gaining the permission of the parent or full legal guardian, appropriately signed, on the membership application form.

The information stored on the computer will be retained whilst that person is a member of the LRSAC but will be deleted after 3 months of the membership lapsing, or earlier upon <u>written</u> request to the membership secretary.

This personal data, which is only available to officers of the club, can be removed at any time, upon <u>written</u> request to the membership secretary. The information will then be deleted from the database and the member leaving will receive a message to that effect from the membership secretary.
